# Fall Forestry Corpsmember (Colorado Springs)



### **Position Description:**

Fall Forestry (FF) is a team-based, 10 week-long program. FF participants (called *Corpsmembers*) serve on environmental stewardship projects on public lands throughout the Southern Front Range region. Corpsmembers will be enrolled in AmeriCorps—a national community service program. No experience is required! We will provide you with hands-on training related to all projects.

#### **Compensation and Benefits:**

- **Biweekly Stipend** Earn a living stipend of \$960 before taxes paid every 2 weeks.
  - Leadership Opportunities available: Corpsmember Drivers are eligible for a living stipend of \$980.
    Returning Corpsmembers earn \$1,000. More information available on request.
- AmeriCorps Education Award Earn a scholarship of \$1,342.86 upon successful completion of the term (300 hours of service). This award can be used to pay tuition, pay back qualifying student loans or go on an expedition through a wilderness school! Corpsmembers have 7 years to use the award.

- Student Loan Forbearance Corpsmembers can apply to put their qualified federal student loans on hold during their term through the National Service Trust.
- Health Insurance Corpsmembers are eligible for health insurance the 1<sup>st</sup> of the month after serving at MHYC for 60 days. Corpsmember contribution required.
- **Counseling -** Corpsmembers receive up to 4 free mental health counseling sessions per year.
- **Networking** Corpsmembers have daily opportunities to network with federal, state and local natural resources professionals and access to a vast alumni network!
- **Training** Depending on crew assignments, Corpsmembers will receive training in one or more stewardship skillsets, including S-212 Wildland Fire Chainsaws (required for sawyers), trail building and maintenance, and pesticide application.

#### **Timeline:**

This is a temporary position from August 22-October 28, 2022.

- 300 hours of service in a 10 week commitment.
- 40 hour weeks, with schedule options including:
  - 4-days over 1 week, *day work*, 7:00 a.m. 5:30 p.m.
  - 4-days over 1 week, overnight camping, 7:00 a.m. 5:30 p.m.
  - o 9-days over 2 weeks, overnight camping, 7:00 a.m. 4:30 p.m.
- All Corpsmembers are additionally required to serve:
  - Friday, September 9 from 7:00 a.m. 5:30 p.m. due to holiday observed on Labor Day (September 5).
  - Friday, October 14 from 7:00 a.m. 5:30 p.m. due to holiday observed on Indigenous Peoples' Day (October 10).
  - Friday, September 16, September 30 and October 28 from 8:00 a.m. 12:00 p.m. for in-house programming, including career readiness training, Diversity, Equity, and Inclusion training and Community Meetings.

MHYC is committed to hiring candidates with unique backgrounds and perspectives. If you are interested in this position but are concerned that you do not meet all of the requirements or possess all of the necessary skills, or that prior convictions or your background might disqualify you, we highly encourage you to submit an application anyway.

#### **Qualifications:**

- Between the ages of 18-24.
- High school or GED/HSE graduate or still enrolled.
- Must be eligible for enrollment in AmeriCorps as a US Citizen, National or Lawful Permanent Resident. Documentation will be required on the first day. Must bring identification documents necessary to complete the I-9 and other forms on your first day.
- Must be physically fit, able to lift 50 lbs., spend 8-10 hours a day in all weather conditions (e.g., sun, heat, wind, rain, etc.) and hike 7 miles with a day-pack.
- Able to be on time and maintain consistent attendance throughout term of service. Must commit to complete the program.

#### **Requirements:**

- Pre-service National Service Criminal History Check required; this position does not have recurring access to vulnerable populations.
- Corpsmembers must not engage in any prohibited activities as listed in the AmeriCorps Member Service Agreement.
- MHYC has a COVID-19 vaccination requirement. Individuals must submit proof of full vaccination, partial vaccination, or submit their COVID-19 vaccination medical or religious exemption request by their first day. If only partial vaccination is submitted, proof of the second shot needs to meet the recommended time interval of the vaccine administered. Please reach out to MHYC staff for exemption forms or more information.

### Corpsmembers have the choice to serve on a variety of technical crews:

**Sawyer Crew:** Corpsmembers operate chainsaws on invasive tree removal and wildland fire mitigation projects. They receive First-Aid/CPR and S-212 Wildland Fire Chainsaws certifications. Some sawyers will have the opportunity to receive pesticide application training. The use of pesticide is common on invasive tree removal projects.

**Hand Crew:** Corpsmembers receive training in safe and efficient use of hand tools to complete a wide variety of projects. Examples include: trail maintenance and construction, noxious weed removal, pesticide application and other park development projects.

#### Corpsmembers also have the option to serve on an Affinity Crew. These crews operate as Land Conservation crews and complete sawyer or hand projects! Affinity Crews are made up of individuals with one or many common identities and are intended to be a space for Corpsmembers to serve alongside individuals with similar lived experiences, share stories, discuss challenges, and explore the field of natural resource management.

**Gender Spectrum Affinity Crew:** This crew is for people of underrepresented gender identities, including transgender and gender non-conforming individuals and cis women, to learn new skills and reduce historical barriers that have prevented natural resource management from being an inclusive field.
